Mental Health Counseling: required services may include but are not limited to individual and group counseling

Drug Testing Collection Procedures and Substance Abuse Treatment: required services may include, but are not limited to, urinalysis collection, sweat patch application/removal, assessments, substance abuse cognitive based counseling (individual, group, and/or family) and transportation.
